(\*The 2011 show exceeded those awards and some of our artists even ran out of merchandise by Sunday afternoon, so plan accordingly...)

### **ENTRY APPLICATION**

Complete the attached application entry form and include two (2) checks, or money orders, made payable to Art For All (AFA) - one (1) for the \$75 booth fee and one (1) for the \$10 non-refundable jury fee. All entries must include this application, fee, and artistic submissions representing your art. This is considered your entry package and it must be received by the **May 1, 2012 deadline**. Priority will be given on the date the completed entry package is received. Any application received after the deadline will require an additional \$10 late fee.

### **ARTISTIC SUBMISSIONS**

Submit 5 color photos/jpegs on a CD of 4 pieces representing the work you will be submitting this year, and include a photo of your booth setup (if available). Artists displaying more than one media must submit same for each media. If 2 artists/artisans share a site, each must submit the required CD. On this CD, print your name on top & the media on the bottom.. All submitted CD's are the property of Art for All.

All work must be original hand work, or prints of originals, finished and display an acceptable level of skill and creativity as determined by our Independent Judges. No items made from kits will be accepted.

### **BOOTH INFORMATION & EXHIBIT**

Artists/Artisans must be present throughout the duration of the show. Artists/Artisans must supply display equipment, including tents, tables, chairs, weights, etc. This is an outdoor show with 12'x12' sites on pavement or brick. Tent stakes or any material that penetrates the ground is not allowed. Should you need additional space for larger works, please indicate so on the entry form. Should you wish to do live art, or demonstrations, please indicate same on the entry form.

Images of your work will be used in event related publicity unless you specifically note otherwise on the application entry form attached. Furthermore, the City of Elgin requires a signed waiver from each artist/artisan exhibiting which is also on the attached form.

### **PAYMENTS & REFUNDS**

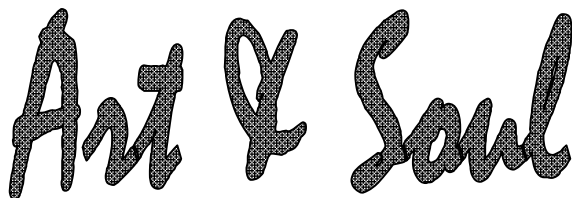
Artists/Artisans who withdraw after submitting an application entry form prior to May 1st and artists/artisans not selected will be refunded 100% of their booth fee. Withdrawal after May 1st but before June 2nd will be refunded 50% of their booth fee—no refunds after June 2nd will be given.
